# Personal data is defined by the General Protection Regulation (EU Regulation 2016/679) (GDPR) as '*any information relating to an identifiable person who can be directly or indirectly identified in particular by reference to an identifier'*

This policy applies to personal data collected, used, shared and stored on clients and prospective clients, suppliers and prospective suppliers, contractors and prospective contractors, artists, contacts and staff of Art Logistics Ltd.

Personal data will be collected, used, shared and stored only where it is lawful, fair, relevant and necessary to do so and with transparency.

## The Legal Basis

The legal basis for the personal data we collect, use and store will vary according to your relationship to us. Personal data will be collected, used, shared and stored only in:-

- Where relevant and necessary for **contractual reasons**. Ie. to carry out our obligations arising from any agreements entered into between you and us and to ensure the performance of contracts to which you have entered with us. - Where relevant and necessary for **legitimate business reasons**, valid and justifiable within the reasonable expectations of individuals to whom the personal data relates. This includes communicating with you and providing you with information about our services and our services to you.

# Sharing of personal data

- We will share your personal information with law enforcement agencies, other governmental agencies or third parties when required to do so by law

- Your personal information may be transferred to, and stored at, a destination outside the European Economic Area ("EEA") and may also be processed by staff operating outside the EEA who work for us, or for one of our service providers, or authorized third parties. We will only transfer your information outside the EEA when we have established the recipient of this data is compliant the security standards and legal bases of EEA GDPR legislation or where the transfer is to a country deemed to provide adequate protection of your information by the European Commission.
- We do not, under any circumstances use your personal data for profiling, research or marketing purposes.

## **Retention of data**

We will only keep the personal data we collect and store about you for as long as required for the purposes set out above. Files are reviewed periodically to check that information is accurate, up-to-date and still required. The review period will be dependent on your relationship to us and the legal basis on which the information was originally collected and continues to be stored.

#### Security

#### Your Rights

You have the right:

- To query the accuracy of your personal data with guaranteed rectification of your personal data, if the information we are holding is inaccurate. All processing of personal data will be restricted until we have verified the accuracy of the personal data we hold.
- To ask us to delete your personal data if required to comply with a legal obligation.
- To ask us to delete your personal data, on reasonable grounds, unless it is required by us for contractual or legal obligations or the grounds for request are superseded by the legitimate interests on which it was collected. During any investigation as to legitimate interests, processing of your data will be restricted.
- To data portability. Ie. to request transfer of personal data to a legitimate third party, providing it is done by automated means and does not affect the rights afforded to the personal data of other individuals.
- To object to our processing your personal data in the interest or exercise of an official authority or to prevent its use for profiling, marketing, research or collection of statistics. We undertake not to use your personal data for profiling, marketing, research or collection of statistics.
